Advanced Development Economics

Winter term 2010/11

The course will take place in VG 4.102 from October 11 to 15; 9:00 am to 5:30 pm.

Purpose

This course provides an in-depth analysis of current research in selected critical issues in development economics at the graduate level. The course will cover the topics of measurement of development and poverty, macro vicious cycles, the role of geography and institutions in development, aid and development, growth, inequality, and poverty linkages, field experiments, collective action, risk and uncertainty, risk sharing, the economics of natural resources, and gender bias in developing countries. Some familiarity with development issues (e.g., Entwicklungsökonomik I, II, or III) as well as background in micro and macro theory and empirical economics is highly desirable. The course is open to Ph.D. students in economics, applied statistics, agricultural economics as well as M.A. students in international economics.
