All of our programmes of study are officially accredited by the ZEvA. They are additionally characterised by a modern infrastructure, high-quality equipped seminar rooms and the modern library for Economic and Social Sciences.

Low rents, 5.000 dorm rooms, a lively bar scene as well as a variety of cultural and athletic opportunities make Göttingen a student-friendly city. The campus, city centre and train station are all within a few minutes' walk of each other.

## Transfer of Knowledge

At the centre of our Faculty's knowledge transfer activities are consulting services for businesses, government departments and international organisations as well as expertise provided to courts of law and other decision-making bodies. We also offer optimisation of teaching and learning modules for initial and continuing occupational and professional education and training. We foster the transfer of knowledge by holding lectures, conferences, seminars, and series of interdisciplinary lectures at home and abroad as well as in business and summer schools.



In addition, our Faculty participates in various international research cooperation and partnerships. International researchers are regular guests who expand the offers for research and teaching at the Faculty. Members of the Faculty of Economic Sciences are always interested in cooperation with businesses and non-profit organisations. Possibilities for cooperation extend from guest lectures and joint seminars to conducting joint studies and research projects as well as the possibility of financing for doctoral positions and Chairs to filling teaching positions and adjunct professorships.

## The Faculty of Economic Sciences

The Faculty of Economic Sciences is the third largest of the 13 Faculties of the University of Göttingen – an internationally renowned research university with an emphasis on research-based teaching. In 2007 the University of Göttingen achieved success with its institutional strategy »Göttingen. Tradition – Innovation – Autonomy« in the Excellence Initiative by the German Federal and State governments.



Ever since its foundation in 1737 the Georg-August-Universität has educated students in the fields of economic sciences. Today the Faculty of Economic Sciences is one of the largest of its kind in Germany. Around 30 professors and 120 academic staff instruct about 3000 students enrolled at the Faculty. Our full-time academic staff is supported by honorary professors and adjunct lecturers, especially in teaching.

The Faculty of Economic Sciences at Georg-August-Universität Göttingen was one of the first German universities to completely restructure its single-tier diploma programmes into a two-tiered Bachelor's and Master's system, starting in the winter semester of 2005/ 2006. The programmes fulfil the requirements for international recognition of the acquired degree and secure a high standard of education. The programme structures, programme contents, teaching and learning methods of the Faculty are innovative and goal-oriented with small groups, project and practical seminars as well as research-oriented offers, especially in the Master's programmes.



The Faculty of Economic Sciences is renowned for offering a large variety of specialisations in research and teaching: Business Administration (including Business Information Systems), Economics, Business and Human Resource Education as well as Economic and Social History – all complemented by the empirical subjects of Statistics and Econometrics. Our research and teaching opportunities are enriched by collaborations with researchers in the neighbouring disciplines of Agricultural Economics, Forest Economics, Social and Economic Psychology, and Economic Geography.

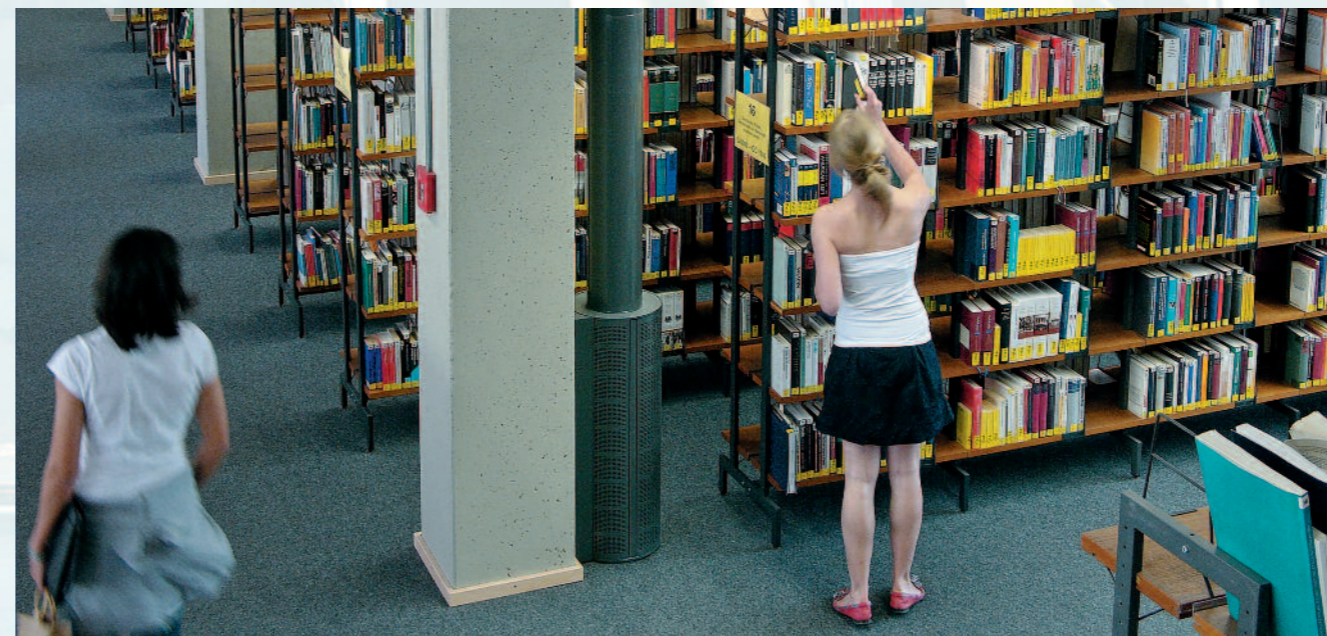
In addition to the various international partnerships maintained in the area of research, many externally-funded research projects have been procured in recent years.

Researchers of the Faculty of Economic Sciences are involved in the new decision-making structures of the University as a result of the Institutional Strategy (»Zukunftskonzept«) that succeeded in the Excellence Initiative, including the Göttingen Research Council (GRC) and University Research Committee.
