The aim of the course is to introduce students of literature to the basic terminological and theoretical apparatus needed for the study of literature in the English language. The necessarily selective contents of the course fall mainly into 3 categories: critical terminology (for poetry, prose, and drama analysis), concepts of literary theory, and British literary history. An introduction to the methodology of academic research is also included (e.g., MLA data bank and bibliographic style).

There will be an announced mid-term test (50%) and a final exam (50%). You will need an overall 60% score to pass this course.

Please note: To ensure a good level of supervision, the number of participants is strictly limited to 25.

Reading: Each lecturer will announce on what required reading the course will be based.

Requirements: Attendance in the first session is mandatory.

In the past two decades, Cultural Studies as an academic field has become more and more important in English studies. As opposed to the traditional *Landeskunde*, which concentrates on the social and cultural history of Great Britain, Cultural Studies is concerned with the theoretical bases of our understanding of cultural, social, and political practices. These theories are concerned with the relation of cultural practices to power, and they focus on aspects such as ethnicity, class, and gender.

This lecture course serves as an introduction to and survey of the field of Cultural Studies. We will begin by looking at the concept of culture as well as its historical development. Furthermore, this series of lectures will provide an overview of several theoretical fields such as British Cultural Studies, Structuralism and Poststructuralism, Postcolonialism, Gender Studies, Theories of the Body, Discourse Theory, or Media

Studies. These topics will be further discussed and explored in the *Introduction to Cultural Studies*-classes accompanying this lecture series. A Reader will be available.

Cultural Studies is an interdisciplinary area of research, exploring the ways and forms in which human beings experience the world. The theoretical concepts which will be analysed are concerned with the relations between cultural forms and their social, political and economic context as well as the symbolic attributions to practices of everyday life.

The module is meant to give students an introduction to and overview of British Cultural Studies. This course is designed to accompany the introductory lecture series on British Cultural Studies (see course no. 454848) and help deepen students' understanding of the texts by discussing the various theories sketched in the lecture series. The focus will be on an active examination of the relevant critical ideas and theories, while the development of British Cultural Studies and the application of theories to fields of literary and cultural practice will also be considered.

Please note: To ensure a good level of supervision, the number of participants is strictly limited to 25.

Reading: A reader with the core texts will be available from Klartext.

Requirements: Attendance in the first session is mandatory.

Ever since the first translation of the *Arabian Nights* was published in the early 18th century, the Orient has held an ongoing fascination for the European imagination. Based on Edward Said's statement that "Orientalism is a Western style for dominating, restructuring and having authority over the orient", this lecture series will look at various, mostly (but not exclusively) British constructions of the Orient over more than three centuries; considering travelogues, music, art, design, advertising, architecture and films as points of reference. It will explore how Orientalist representations have served or expressed cultural and racial anxieties and colonial policy, it will investigate the main counter discourses that have emerged, and it will challenge and complement Said's view by introducing the category of gender – neglected by Said - as an analytical tool to analyse Western concepts of the Orient.

Haekel	A Survey of British Literature and Cultural History: The Early Modern Period VL

During the 150 years covered in this lecture course, the British Isles witnessed a number of changes and revolutions that still can be felt today. The Protestant Reformation, the colonization of Ireland, and the British Civil War fundamentally shaped modern Great Britain and Ireland. Furthermore, literature written in Renaissance England is immensely rich, ranging from Elizabethan sonnets, long poems over plays to literary theories and extended prose texts. This lecture course will provide an overview of the scope of Early Modern literature and culture. We will look at the development of British Society from 1500 to 1660, read and discuss texts by authors such as Thomas More, Philip Sidney, Edmund Spenser, or John Donne. Special focus will be put on Elizabethan drama and theatre, particularly on the works of William Shakespeare. Watch out for the syllabus on StudIP. A reader will be available two weeks before the beginning of term.

In Shakespeare's *Macbeth*, we meet a Scottish tyrant who ends his life slain by another Scotsman, Macduff. Macbeth's murder of Duncan is triggered by the prophesy of the three "weird sisters" that he will become king of Scotland. Are all Scotsmen superstitious and barbaric to the Elizabethans and Jacobean? *Romeo and Juliet*, like *The Merchant of Venice* and *Othello*, are set in Italy. In all these texts, people are killed, murdered or slain in duels, out of jealousy, spite or envy. Are all Italians as hot-blooded and impetuous, without morals? - What did the Elizabethans and Jacobean know of the world outside England? How did they think about foreign countries, and what ideas did they have about them (and about themselves)? This course will analyse both the common knowledge of countries abroad and their literary reflections around 1600. We will read descriptions of the world from England and the Continent, investigate their various structures and uncover their prejudices and errors, and we will attempt to explain the depiction of foreigners in literary productions.

Reading: The key texts will be provided in electronic copies on StudIP towards the beginning of the semester. Any reading assignments for the first meeting will be announced there, too.

This course will focus on the revenge tragedy as one of the most prominent dramatic subgenres of the Elizabethan and early Jacobean Age. We will consider plays by Kyd, Marston, Shakespeare, Tourneur and Webster in order to analyse stylistic and formal conventions (e.g. the highlighting of theatricality via plays-within-the-play), recurring themes such as violence, madness, excessive passion and honour as well as frequent motifs such as the apparition of ghosts and other supernatural phenomena. The discussion will also revolve around the historical context of the plays with regard to performative practices, political or social developments and historical discourses on morality, Christian forgiveness and the legal system.

Readings: Thomas Kyd, *The Spanish Tragedy*; John Marston, *Antonio's Revenge* (1600); William Shakespeare, *Hamlet*; Cyril Tourneur, *The Atheist's Tragedy*; John Webster, *The White Devil*

We shall read three of Shakespeare's plays, tackling some central questions such as: Who is the "Other" in Shakespeare's plays? What are the reasons and strategies for the construction of Otherness? How does the image of the Other mirror and support the image of the Self?

Reading Shakespeare is challenging – but it's not impossible and can actually be fun. To give you a better understanding of Shakespeare's comedies, we'll focus on three plays, examine their origins, distinctive features, and key themes such as courtship and marriage. We will explore the conventions of (Renaissance) dramatic comedy and investigate Shakespeare's development from the early comedies to the later ones as well as his particular contribution to the genre. Furthermore we'll have a look at the importance of the plays throughout the centuries including their adaptation in films. Please note: The course will be held as a blockseminar on two weekends.

As far as the Early Modern period is concerned, a clear distinction between science and magic cannot be drawn. On the contrary: even though the occult designates an undisclosed and concealed, a secret and even hermetical knowledge, while it refers to magic, alchemy, or other practical arts held to involve agencies of a secret or mysterious nature – it is nonetheless a valid method of acquiring knowledge. The theatrical staging of conjurers, alchemical experiments, and even devils was nothing out of the ordinary. Queen Elizabeth I herself employed a noted occultist and alchemist as official consultant.

In this seminar we will take a look at how the occult is represented in early modern discourse and drama, that is, how science, magic and literature coincide in their theatrical performance. In addition, we will try to reconstruct the occult as a fascinating part of Early Modern philosophy and everyday life.

Readings: Texts will include Christopher Marlowe's *Doctor Faustus* (ed. David Bevington / Eric Rasmussen; Oxford World's Classics); Ben Jonson's *The Alchemist* (ed. Gordon Campbell; Oxford World's Classics); William Shakespeare's *The Tempest* (ed. V. Vaughan, Third Arden).

This seminar will take a look at the most important period in the history of English drama and theatre. The Early Modern stage, especially during the two decades around the turn of the 17th century in which William Shakespeare was active, exercised a massive influence not only on English but on European drama and theatre for centuries to come. Not only Shakespeare but also other important playwrights such as Thomas Kyd, Christopher Marlowe, or Ben Jonson participated in a complex system of acting companies, professional theatres, and patronage, etc. that shaped this particular form of Elizabethan tragedy and comedy. Only the entire picture helps us to understand the significance of the individual plays. In order to analyze a play we will therefore try and reconstruct the staging conventions, acting techniques, financial organization, structure of the audience, etc. Since we will also watch a performance, the choice of plays depends on the programme of the Edinburgh Festival (so watch out for further information on StudIP).

Beginning with an overview of the *Gaeltacht* (Irish-speaking) regions, this module explores the Irish language primarily in a contemporary context. Three key authors will underpin this module. These include Brian Friel and his play *Translations*, which has been described by its author as 'a play about language and only about language'. Students will also explore *A Speckled People*; a language memoir written by Hugo Hamilton, the son of a German mother and an Irish father. Hugo grew up in Dublin in the 1950s wearing 'lederhosen and Aran sweaters, smelling of rough wool and new leather, Irish on top and German below.' His family spoke both Irish and German, but English was strictly forbidden. The memoir explores issues of language identity and belonging in contemporary Ireland. Finally students will be introduced to the bilingual poetry of Nuala Ní Dhomhnaill – one of the finest contemporary female voices in Irish/Gaelic. This section will explore why a writer might choose to write in a language that is not internationally understood. While the seminars will focus on issues of language, identity and belonging, there will also be an opportunity to hear and speak some Irish.

This module aims to explore the fluidity and complexity of British and Irish cultural narratives in Northern Ireland/Ulster. Students will critically analyse different cultural traditions and assess to what extent these are products of historical and contemporary political manipulation. The module will explore the significance of history and memory for the construction of 'dual traditions' as well as the role of visual culture and museums in the consolidation of loyalties. While the primary focus of the module is the polarisation of the population into 'British' and 'Irish' groups, these cultural identities will be set in the context of the full spectrum of Northern Irish cultural diversity. Attention will be given to indigenous cultural identities such as the Travellers as well as to incoming populations that have arrived in the Province in recent decades.

The objective of this course is to examine lyrical representations of geographical and scholarly explorations and to assess them against the background of developing notions of self- and national identity. The self is an ambiguous concept. It suggests sameness – “I am myself because I am the same as yesterday” – as well as otherness – “I am myself because I am not

somebody else". Far from being an a-historical reality, the reflexive knowledge of the self as individual identity is an historical construct which has changed significantly from 1500 to today. In the Renaissance, the self was regarded more consciously as something which can be fashioned; during the late 19th century it became a matter of class and gender; in the 20th and 21st centuries selfhood became a matter of critical debate in philosophy, as well as in cultural and postcolonial studies. During the course we will look at literature, critical and philosophical texts on the self and on selfhood from the Renaissance up to today.

Heritage has traditionally been associated with material objects, but recent international conventions have emphasized the significance of intangible culture heritage. This module advocates a holistic approach towards the concept of heritage and considers key challenges for Europe at the beginning of the twenty-first century. Reflecting on the notion of 'European', it considers the question of how one defines European heritage and which European heritage is to be protected. It explores links between national and European conceptions of identity and heritage and queries issues of ownership, language and representation. A number of ethical issues will be raised during the module – such as the role of women in the transmission of heritage and the

implications of information technology for copywriting traditional practices. The module will also query how one ensures that the process of globalisation facilitates rather than eliminates local cultural heritages.

This course will discuss a distinctively Scottish tradition of the Gothic, starting with James Hogg's *The Private Memoirs and Confessions of a Justified Sinner* as a Romantic exploration of the self, moving on to Victorian Post-Darwinian anxieties as expressed in Robert Louis Stevenson's *The Strange Case of Dr Jekyll and Mr Hyde*. More recent and contemporary Scottish fiction (Ian Banks, *The Wasp Factory*, James Robertson, *The Testament of Gideon Mack* and John Burnside, *Glister*) will provide us with insights into postmodern contemporary Scottish literary representations of the dark, uncanny and macabre. Part of the course will also be devoted to the making and marketing of Edinburgh as a "gothic" literary city.

All texts should be read by the beginning of July, when we will meet for a final adjustment of the schedule and distribution of the presentations. A recommended first introduction to the topic is David Punter's *Companion to the Gothic*, chapter 6, Blackwell 2001.

Food plays a most significant role in our culture: it relates to our identity (we are what we eat) and concepts of class, it has a rich tradition of symbolic meanings, it informs the ways in which we build our social relationships, and, last but not least, the production and consumption of food is of significant ethical relevance. Having emerged from World War II as a world power, the United States faced numerous problems of cultural self-definition in the second half of the twentieth century. While the Cold War imposed a role of international leadership on the nation, American culture was frequently ambivalent about its new position in the world. Domestic developments and crises—such as the advent of a post-industrial economical order, suburbanization, a new protest culture, the decline of the liberal consensus, political assassinations, culture wars, 9/11—contributed to a widespread sense of unease concerning the meaning and coherence of American culture. Today, after the end of the Cold War and with the onset of America's military hegemony and its possible economic decline, many of these problems of self-identification have been radicalized in unexpected ways.

As a result, the years between 1945 and 2010, showing the U.S. at its most powerful and prosperous, have been marked by more anxiety and more discontent than any other period in American history. Cultural production within this era was almost always innovative, often playful, frequently belligerent, sometimes outrageous and hilarious. It gave us the Beat Movement, the counter-culture of the sixties, pop art, the New Hollywood, postmodernism, new ethnic literatures, cyberpunk, neo-realism, HBO, McSweeney's, the Internet.

In this lecture course, we will discuss selected phases and moments of American cultural and literary history after World War II. Readings will include poems by Robert Lowell, Sylvia Plath, Adrienne Rich, Allen Ginsberg, Frank O'Hara, and John Ashbery;

plays by Tennessee Williams, Arthur Miller, Sam Shepard, and David Mamet; prose by John Updike, Andy Warhol, Thomas Pynchon, Bret Easton Ellis. We will also be concerned with various ethnic literatures after 1945, such as African American literature (Ralph Ellison, Amiri Baraka, Toni Morrison), Jewish American literature (Saul Bellow, Cynthia Ozick, Philip Roth), Native American Literature (Louise Erdrich, N. Scott Momaday, Gerald Vizenor), and Chicano/a Literature (Gloria Anzaldúa, Sandra Cisneros, Richard Rodriguez). For a final selection, see syllabus.

Ever since the days of the slave narrative, African American literature has negotiated questions of history, heritage, and identity. Yet out of all the literary genres employed for such negotiations, the performative genres lent themselves most effectively to the purpose of political education and agitation. This class will deal with African American drama and theatrical performance in the 20th century. After a brief discussion of works that paved the way for the mid-century protest theater, such as those written during the Harlem Renaissance, we will focus on texts written and performed during the times of political and social upheaval in the 1950s, 60s, and 70s. We will conclude our survey with an outlook on recent dramatic works by African American authors and the way they adapted their literary predecessors' work to the political, social, and psychological conditions of the late 20th and early 21st century.

Our discussion will include plays by Langston Hughes, Amiri Baraka, Adrienne Kennedy, James Baldwin, and Suzan-Lori Parks, as well as other sources (such as sound recordings, poems, and essays), which will provide the historical, theoretical, and ideological backgrounds of the plays alongside with means to analyze and interpret the aesthetics of their theatrical performances.

Organization: In conjunction with Daniel Stein's course on the poetry of the Beat Generation, we will organize a one-day student conference toward the end of the semester. Attendance is required; a limited number of students will be encouraged to present papers on various topics for extra credit ("Schlüsselkompetenzen").

When Allen Ginsberg's long poem *Howl* was published by Lawrence Ferlinghetti's City Lights Press in 1956, it marked a decisive change in American post-war poetry. Its sexual explicitness, vivid depiction of drug addiction, and exploration of religious experience as well as its vocal protest against the social conservatism of the Eisenhower era served as the focal point of what Jack Kerouac had labeled the "beat generation" in the late 1940s: a group of writers congregating mostly in San Francisco whose writings represented countercultural views. Besides Ginsberg, Ferlinghetti, and Kerouac, these writers included Gary Snyder, Gregory Corso, Michael McClure, Robert Creeley, Philip Whalen, Diana di Prima, Denise Levertov, and Leroi Jones. The objectives of this course are threefold: Our main objective is to conduct extended close readings of poetic structures and devices in works such as "Howl," "A Supermarket in California," "Kaddish" (Ginsberg), "I Am Waiting" (Ferlinghetti), "Mexico City Blues" (Kerouac), and "Preface to a Twenty Volume Suicide Note" (Jones), etc. Our second goal is to study these poems as performances, analyzing for instance, sound recordings of historical readings and recitations accompanied by jazz musicians. Our final aim is to place the poetry of the beat generation in the wider context of American literary and cultural production.

Organization: In conjunction with Diana Rosenhagen's course on African American Drama, we will organize a one-day student conference toward the end of the semester. Attendance is required; a limited number of students will be encouraged to present papers on various topics for extra credit ("Schlüsselkompetenzen").

War literature has always been an important site of American self-reflection and self-definition. However, with the onset of American military and economic hegemony after 1945, new ways of describing, representing, and narrating war emerged, different from earlier American war literatures. In this course, we will investigate (1) how new types of warfare after 1945 (in particular, Vietnam and Afghanistan/Iraq) provoked new modes of literary or artistic representation, and (2) how American postmodernism, in turn, revisited and re-evaluated earlier wars (in particular World War II).

Our core texts are: Kurt Vonnegut, *Slaughterhouse-Five* (1969), Tim O'Brien, *Going After Cacciato* (1979), Michael Herr, *Dispatches* (1977), Paul Haggis's movie *In the Valley of Elah* (2007), and *Generation Kill*, both the book by Evan Wright (2004) and the HBO series by David Simon and Ed Burns (2008). In the first part of the course, we will discuss the novels by Vonnegut and O'Brien in detail; in the second part, students will select parts or topics from the other texts. Additional texts and topics are welcome (e.g., Thomas Pynchon, *Gravity's Rainbow*, 1973; Dexter Filkins, *The Forever War*, 2008).

Required Reading: All participants *must* have read Vonnegut's *Slaughterhouse-Five* and O'Brien's *Going After Cacciato* before the semester starts.

Today, in the United States, civil rights has come to mean the right to be free from discrimination on grounds of race, ethnicity, religion, gender, disability or sexual preference. Until the latter half of the 20th century, however, protection of civil rights was very limited, because the *Bill of Rights* applied to federal law only and not to state law. In many parts of the US, numerous state laws were passed—among them the infamous Jim Crow legislation—which excluded African Americans from full participation in society. In the area of racial and ethnic equality as in areas such as women's rights, gay rights, and religious equality, the various civil rights movements in the US have greatly contributed to political action, legislation, and Supreme Court decisions leading to dramatic changes in American society. We will discuss the historical contexts of civil rights and read legal, political, and personal discourses evolving out of the civil rights movements.

Requirements: attendance of all the sessions, reading assignments, one in-class presentation with handout; written paper (for full credit).

Registration: students must have signed up for a topic before the beginning of the semester and read the assignments for the April sessions. This is the second part of a set of two courses, focussing on the translation of poetry, literary prose, and drama. You may enroll even if you did not attend the first part. Translations are media of interlingual exchange and of intercultural contact, communication and transfer. Through the centuries they have played a significant, though rarely acknowledged, part in the cultural histories of many nations. Literary translations, whether identified as such or not, have frequently contributed to the repertoires of autochthonous texts, thereby enhancing not just "national" literatures but entire cultures. Traditionally, a number of academic disciplines such as theology, philosophy, classics, and more recently, linguistics and literary studies, including comparative literature, have taken an interest in translation and related phenomena. Their presuppositions, aims, purposes, and methods differ, and—inevitably—so do their results. Explicitly or implicitly, many traditional studies are source-text oriented and prescriptive, sharing the premise that a translation should be the equivalent of or equivalent to its source text by adequately reproducing its meaning, its form, its structure, or its effect (or whatever an individual theorist may consider to be the essence of literature). Given its essentially subjective, ahistorical, and unsystematic character, this premise is unsuited for the purpose of historical research. Requirements: Regular attendance, active participation. Teilmodulprüfung (1): description and analysis of the translation of a literary prose text (8-10 pages).

In MS Harley 2253 Middle English poetry hits one of its peaks. As a cognitive system language is part of a human being's mental or psychological

structure raising fundamental questions such as
 -What is the nature of the cognitive system which we identify with knowing a language?
 -How is this system used in our production and comprehension of speech?
 -How is this system represented in the brain?
 Knowing a language can be identified with having a mentally represented grammar. This grammar constitutes a speaker's competence in that language which is contrasted with performance, the comprehension and production of speech. After a quick revision of the foundational concepts of phonology, morphology and syntax we will address the question of how the mentally represented grammar is employed in the production and comprehension of speech. The analysis of speech errors and preferred readings of ambiguous structures gives insight into the work of the phonological, the lexical and the syntactic processor and the structure of the mental lexicon. Looking at language disorders allows hypotheses about the representation of linguistic knowledge in the brain.

This seminar investigates the meaning of evaluative adverbs e.g. *sadly* in (1a) *Sadly for Steve Martin, the Pink Panther is just one of those jokes that gets lost in translation*. We will discuss their meaning contribution to the sentence, for example by comparing them with their adjective counterparts e.g. *sad* in (1b) *It is sad that the Pink Panther is just one of those jokes that gets lost in translation*. Another issue is that when the *for-PP* is absent in overt syntax, i.e. *Sadly, the Pink Panther is just one of those jokes that gets lost in translation*, to whom does the speaker attribute the sad emotion to, i.e. to the speaker herself or to a contextually salient individual like Steve Martin? Is the truth value of such sentences also relative to a judge parameter, as is proposed in recent

analyses of predicates of personal taste e.g. *fun/tasty?* We will use techniques of formal semantics and pragmatics for analyzing the meaning of natural language sentences with these adverbs.

We shall also examine contemporary Optimality Theory.

The class aims at offering you active command of standard formal tools. It is suited for MA students and advanced BA students with an interest in formal theory.

In this Hauptseminar we will look at an aspect of English grammar which poses a challenge for learners of English as a second language: tense and agreement. Some inflectional affixes (e.g. past tense *-ed*) are simple in the sense that they encode just one piece of information. Others (e.g. 3rd pers sg *-s*) are complex in the sense that they spell out tense, agreement and mood information in one single affix (*portemanteau morph*). Agreement morphology as a clausal phenomenon is predicted to be acquired only after word level or phrase level morphology according to the *Processability Theory* (Pienemann 2003) of language acquisition. Much work on functional categories in L2 acquisition has addressed the question of the presence and the specification of these categories and the morphological and syntactic consequences. We will discuss several hypotheses according to which missing functional items (tense and agreement morphology) in the utterances of learners reflect missing functional categories in their syntactic representation.

The course will make reference to the thematically related course by C. Hecke: "Teaching Grammar". We plan to meet two times in the course of the semester discussing the different perspectives of linguistics and teaching a language.

The term "New Englishes" refers to varieties of English in countries such as India, Kenya, or South Africa, where English is an official language, but typically not the first language of the majority of the people.

Depending on the region, we find different types of varieties of English, such as native varieties, second-language and foreign-language varieties, lingua franca English, pidgins and creoles. After an introduction to the global distribution of New Englishes we will consider some of these varieties in more detail, discussing the following topics:

- morphological and syntactic properties of various New Englishes and a comparison across varieties.
- sociolinguistic aspects of New Englishes.
- tools for the study of variation (corpora, questionnaires, interviews).
- the status of data from non-native varieties for theoretical linguistic research.

This class is also designed to prepare students for the non-syntactic topic of the written part of the final exam (July 2010).

Formal semanticists attempt to characterize the meaning of constructions and words in natural language with the aid of logical tools. Indefinite phrases like *some*, *a*, *ein* or *irgendein* pose interesting challenges for this enterprise. While in some respects indefinites pattern with quantifiers (i.e. with words like *every*, which we use to make general statements), in others they seem to act more like proper names such as *John* or *Mary*. The study of this puzzling behavior has proved crucial for developing general theories about the semantics of natural languages, and in particular about how quantification works in natural language. Furthermore, indefinites differ among themselves in ways yet to be understood. In this course, we will undertake a hands-on investigation of the semantics of several indefinite phrases. While we will take previous research as our starting point, we will often venture in unknown territory and hopefully make some discoveries along the way. A central part of our project will involve determining across which dimensions indefinites can vary, both within a language and cross-linguistically (what are the differences, e.g., between *ein* and *irgendein*? And between *a* and *some*? Do *ein* and *some* behave alike?). The empirical focus will be on English and German, but we may also consider data from other languages, such as Spanish or Italian. Familiarity with the basic tools of truth-conditional semantics will be presupposed.

Teachers can be considered performers in the classroom: they fulfil various roles, not only according to their different functions (motivator, mediator, evaluator, guide etc.), but they also perform their own identities according to gender, ethnicity, sexuality, socio-cultural background etc. As teachers-to-be, we have to be aware of taking part in shaping roles and identities of our students, through our own performance and representation as a role model (or anti-example), as well as through attribution and ways in which we deal with students. A consciousness of these dynamics is crucial in order to do justice to heterogeneity in the classroom.

In this course, we want to discover and reflect ways of identity construction and attribution in classroom behaviour, content, and language – especially in the Foreign Language Classroom, this also constitutes an important step towards the overall goal of Intercultural Competence. Role plays, texts and media will serve as a trigger for irritation and discussion of strategies, and lead to a more reflected way of acting in class.

The combination of discovering learning, drama exercises, discussions and theory requires a different time frame than the usual 90 minutes. Therefore, the course is scheduled regularly on Thursdays from 6-8 pm only for the first 6 sessions of the term. The second part will take place as a *Blockseminar* at a date to be agreed on in the first session.

Learning a foreign language implies learning words and becoming familiar with the language's grammar. Therefore at school, students spend a lot of time learning vocabulary by heart and studying and practicing grammar. You as future teachers will face the task to help your students developing grammatical skills together with extending their lexis. To prepare you for this job, we offer you this class: we will ask the question, how children learn grammar of a foreign language. For this, we will consult the field of linguistic research. Then, based on their findings, we will try and discuss different teaching methods and learning strategies.

This class will be taught in cooperation with Hildegard Farke's advanced seminar "Acquisition of Tense and Agreement in L2 English". Attendance of both classes is not required but recommended. During the semester, both classes will meet twice (90 min.) for an exchange. We will discuss teaching and learning grammar from two perspectives – linguistic and didactic.

Also, to offer you the chance to gain some first-hand teaching experience there will be an additional free private lessons class for students from Göttingen schools (Tuesdays 4-6 p.m.). Students from Göttingen schools will be invited to come to an extra 90-minute class to practice specific grammatical phenomena or to extend their vocabulary. Each week, one or two university students will have the chance to teach this class and to find out about the effectiveness of the methods and strategies discussed in the Wednesday seminar.

For credit,

- the M.EP.03-1b-L students have to teach one Tuesday session. Later on, they do their internship and write a report (4,000 words).
- the M.EP.03-2-L students have to develop a lesson sequence on teaching words and/or grammar.
- the Vertiefung mit schulpraktischen Anteilen students ('altes Lehramt') have to teach one Tuesday session and write a report and analysis of this lesson (4,000 words).

Aims

This course aims to practise, develop and (hopefully) perfect the linguistic skills and communicative strategies typically used in more formal academic and non-academic discourse in English, e.g. oral presentations (papers, reports) and participating in, leading and summarising discussions inside and outside the classroom.

Topics

Topics to be presented and to be discussed will all focus on Scottish life and institutions (Scottish 'Landeskunde'), which will include the following: Devolution – The Scottish Parliament, The Kirk, The Scottish School and University System, Scottish Art, and others.

A central idea of this course is to combine classroom work on these topics with "practical sessions", i.e. **excursions** to places/institutions related to these topics where experts in the field in question in each case will give us first-hand information on the spot, thus deepening our understanding of the topics discussed. **You must take part in at least two excursions!** Some of these may require you to pay a fee!

Requirements/Credits

This class can be fully credited for the modules stated above, which means that you must have successfully completed **B.EP.02** (Basismodul) before you can take this class.

To have this class credited, you will (a) have to give a 30-minute presentation (group of two with identifiable individual contributions – will basically have to be prepared at least content-wise before we go to Edinburgh!); (b) lead a classroom discussion and give a summary of such a discussion OR give a short oral report of approx. 15 minutes on an excursion (individual presentation); (c) take part in at least two excursions organised for this class.

You must have registered for this class on StudIP and your registration must have been confirmed by me personally. Attendance will have to be limited to 20.
