As a student from Göttingen, you begin your studies in October at your home institution by completing five compulsory modules of the MA Development Economics programme. The second (late Jan. - early June) and third semesters (mid-July - mid-Nov.) are spent in Stellenbosch, where 30 ECTS in the mandatory courses »Microeconomics«, »Macroeconomics«, »Dynamic Economic Theory«, and three elective courses are required. Students are advised to write the master's thesis between their third and fourth semesters (Nov. - Mar.). The 4th semester is spent in Göttingen, completing the compulsory course »Development Economics II«, one seminar among three elective seminars in development economics and three elective specialization courses of the MA in Development Economics.

Students may elect to write their master's thesis at either Stellenbosch or Göttingen. The examination regulations of the university in which you write the thesis are applied. Students will be supervised during the course of their master's thesis by two supervisors, one from each university. Both examiners will participate in the grading of the thesis. The programme coordinators are also available to support the participants in the selection of their supervisors. The thesis will be recognised across both master's programmes, irrespective of the university at which the thesis has been written.

What is Special about this Degree Programme?

The partnership between the two universities offers a unique research-oriented two-year English-language programme that combines the studies of applied development economics and agricultural economics with a strong emphasis on quantitative methods. The focus of the programme is to prepare students to think analytically and to equip them with cutting-edge research techniques, as well as in-depth knowledge of the driving forces behind economic development.

The MComm in Economics comprises advanced study in macro- and microeconomic theory, applied economics and policy analysis. Moreover, special emphasis is placed on research methodology and econometric analysis. Within the development economics courses, the economic and socioeconomic situation in South Africa is also analysed through empirical case studies.

The MA in Development Economics is the only universitylevel master's programme in development economics in Germany. The extensive course offerings in the field of development economics (emphasizing quantitative methods) allow students to specialize in their specific area of interest. These courses teach students the tools used in modern economic analysis, such as using quantitative and statistical techniques to evaluate (development) policy. The programme also equips students with a deep understanding of macroeconomic issues such as trade, capital flows, and aid, as well as microeconomic factors such as poorly functioning markets. Institutions, norms, and governance at all societal levels and the influence of seemingly unrelated concepts of economic development (e.g. gender or conflict) are also crucial to gaining a holistic understanding of development economics.

Subsequently, the programme equips students with key tools for independent research and applied work in the development sector. Additionally, students are trained to communicate effectively with researchers, policymakers, and practitioners in the field, and learn how to advise governments and international institutions on development problems.

Study Programme for Students from Stellenbosch

Students from Stellenbosch will spend their first (early Feb. early June) and second semester (mid-July - mid-Nov.) at their home institution. There, they will complete the mandatory modules of the MComm in Economics. Students are advised to complete their master's thesis between the second and third semesters (Nov.-Mar.). Students also have the option to write their master's thesis either in Stellenbosch or in Göttingen. The third (mid-Apr. - early Aug.) and fourth semesters (mid-Oct. - late Feb.) will be spent in Göttingen where the mandatory courses »Development Economics I«, »Development Economics II«, »Development Economics III« and »Socio economics of rural development and food security« must be completed. The remaining 36 ECTS are acquired by completing one seminar among three elective seminars in development economics, one elective course in econometrics and four elective courses in development economics.
