## Application process

"The city that creates knowledge": Since its foundation in 1737, the Georg-August-University has shaped life in Göttingen – the city lives from science and for science. Of the roughly 120,000 people living here, more than 30,000 are students, and 14 percent of them are international students from more than 120 different countries, appreciating the many perks Göttingen has to offer apart from its excellent university.



- Atmosphere: Göttingen is big enough yet not too big, it is warm, lively, and vibrant - you could easily meet your classmates after the lectures in one of the cozy cafes close by – but it's also easy to escape campus life alltogether for a little while: in Göttingen's many sports facilities, theaters, bars, concert halls – you name it!
- Short distances: the campus, train station, and city centre are all within walking distance from each other. You can get virtually everywhere quickly and independently from public transportation (which is highly reliable and also free-of-charge for students) by bike a means of transportation very popular around here. Indeed, so popular that Göttingen introduced the first German bike highway reaching across major parts of the city, so now you can get even faster from A to B.
- ► Affordability: costs of living in Göttingen are estimated at about € 800 monthly (assuming living in a shared apartment or student residence).
- Superb student union infrastructure: 4,500 dorm rooms, six university cafeterias, excellent sports facilities, "culture season ticket" offering free or highly reduced entry fee to cultural events in the city.



If you completed an undergraduate degree within the field of economics with a sound basis of economic theory and quantitative methods, speak English fluently, and would like to embark on a career of a development economist, we look forward to receiving your application!

Programme start is every winter and summer term, application is possible from October 1 through November 15 of every year for the subsequent summer term and from April 1 through May 15 for the fall intake (winter term).

You will require certified copies of your degree certificate (if already issued) and transcript of records, proof of English proficiency, a CV and a letter of motivation for application.

# Degree Programme Profile

## Content & Structure

Understanding economic development is one of the key challenges of our lifetime. We live in a world of tremendous inequality in the distribution of income and wealth. People live in extreme poverty, poor health and insufficient educational opportunities are a daily reality for the many. Yet recent decades have also shown that economic development and poverty reduction are possible. Many countries in East Asia, as well as some in South Asia, Latin America and Africa were able to grow, develop, and reduce poverty at phenomenal rates.

The challenge for development economics is to understand the drivers of successful economic development in parts of the world as well as to analyse the conditions responsible for stagnation and regress in others. This includes macroeconomic issues such as trade, capital flows, and aid, as well as microeconomic issues such as poorly functioning labour, land, technologies, inputs, credit and insurance markets. Institutions and norms at the village level need to be studied as much as governance issues at the macro level. Cross-cutting issues such as gender inequality or conflict are also critical to understand.

The English-language Master of Science in Development Economics is jointly offered by the Faculty of Business and Economics and the Faculty of Agricultural Sciences and has been in place since 2011, building up on successful, longrunning master programmes that already had a strong specialization in development issues.

Its wide course offerings, one semester stay abroad or field work, master's

thesis and specialization in agricultural economics or economics will enable students to analyse current issues in development economics and prepare them for careers in research or policy.



#### Among the key features of the study programme are:

- Four compulsory courses in macro and micro development issues, econometrics, and rural development,
- Specialization and profile courses to choose from a wide array of development relevant subjects,
- Supplementary courses offered by guest lecturers from other European universities or developing countries,
- Opportunities to take optional courses in six other master's programmes in the faculties of agricultural sciences and economics as electives,
- Opportunities for internships at institutions of development cooperation, international organizations, and research think tanks,
- Opportunities for hands-on research experience within our many research projects,
- Opportunities for field work and research experience in developing countries,
- A semester abroad at one of our partner universities (e.g. in South Africa, Thailand, China, India, Indonesia, Colombia, Mexico, Brazil, Trinidad & Tobago – to name just a few!) and many different language courses are offered to round off the programme.

The University of Göttingen has Germany's largest internationally visible concentration of development economics researchers. The M.Sc. Development Economics offers the great advantage of drawing from long-standing research and teaching experience of two faculties, both deeply committed to development issues: the Faculty of Business and Economics, one of the largest in Germany, with around 4,300 enrolled students and more than 30 professorships (of whom six focus on development economics), and the Faculty of Agricultural Sciences, in particular the Department of Agricultural Economics and Rural Development with 9 chairs.

These groups not only work at the forefront of cutting-edge development research, but they also are part of international research and policy networks and regularly advise governments, aid agencies, and international organizations such as the World Bank and the United Nations Development Programme on key development issues. Some of the subjects our faculty are conducting research and offering classes in include development aid, gender and development, global health, food security, rural sociology, behavioural development economics, trade, demography, resources and environment – and many more.

Students in the Master of Development Economics programme have the opportunity to acquire a second degree either from Stellenbosch University in South Africa (Master of Commerce in Economics) or from the University of Florence in Italy (Master of Economics and Development).
