1. General information

1.1 Course content

This course discusses regional perspectives in economic development of the past decades. The regions considered will be South and East Asia, Sub-Saharan Africa, and Latin America. Emphasis will be placed on a comparative analysis employing both macro and micro perspectives. More specifically, the course covers the following topics:

1.2 Course goals

By the end of this course the students will be able to understand key theoretical and empirical concepts in development economics. They will also understand the differences in regional economic development. The course focuses on the differences in development experiences of East Asia, South Asia, Latin America, and Sub-Saharan Africa and the most important determinants of these differences.

There are no formal requirements, but knowledge in the following areas is highly recommended: econometrics, microeconomics, macroeconomics, and development economics. We highly recommend that students take the following classes in preparation of this course:

2.3 Examination and grading of the module

The grading consists of two components:

The term paper is a referee report where students summarize and critically discuss a research article. In the exam, students demonstrate their ability to apply their knowledge of development economics theory and empirical assessments to interpret and explain key issues affecting regional economic development. In order to pass the course, students need to receive a 4.0 or better on both final exam and term paper.

2.4 Course materials

- We will discuss research papers in each lecture. The required readings will be announced in two reading lists (Lay/Fuchs) on Stud.IP.
- Supplementary course materials will be announced at the beginning of each lecture and/or published on Stud.IP.

3. Term paper requirements

The term paper is a referee report. The length of each referee report must not exceed 3 pages. The cover sheet, reference list, figures, and tables (if any) are excluded from the page count. Please use the following formatting: Font size: 12 pt, line spacing: 1.5 times, alignment: justification, margin (right, left, top and bottom margin): 2.5 cm each. Please make sure that you are consistent in your referencing and bibliography.

Use a referencing style that is in line with basic conventions in the economics literature. Always quote within a work using the same method. The Chair recommends the in-text author-year citation style (see, for example, information sheet "Citation according to the Harvard system"). All sources that you

have cited in the text must appear in the reference list. Everything that you have only read but not

cited in the text must NOT appear in the reference list. Referee reports need to be written in English.

The work must be done independently by the student.

Every idea, statement or fact taken from the refereed paper or any other sources must be appropriately

cited. Quotes need to be indicated as such. Plagiarism is sanctioned with the grade 5 (failed). The

general rules of the Faculty of Business and Economics apply. A signed declaration must be attached

to each scientific work: "I hereby declare that I wrote this referee report independently, without

assistance from external parties, and without use of other resources than those indicated. All

information taken from other publications or sources in text or in meaning are duly acknowledged in

the text. I give my consent to have this thesis checked by plagiarism software."
