Academic Program:

We offer a wide range of [English-taught courses](#) in the field of business and economics on undergraduate as well as graduate level. Exchange students are free to choose English-taught as well as German-taught courses (if interested).

- **Courses in Business Administration** with a special focus on Management, Marketing, HRM, Finance and Controlling, Asian Business and Taxation
- **Courses in Economics** with a special focus on Econometrics, Development Economics, International Economic Policy and Statistics

Language Requirements:

Students should be fluent in English (at least level B2). German language skills can be beneficial for living in Göttingen but are not required. [Free German language courses](#) are offered during the semester.

- The exam period is usually three weeks after the period of lectures end.

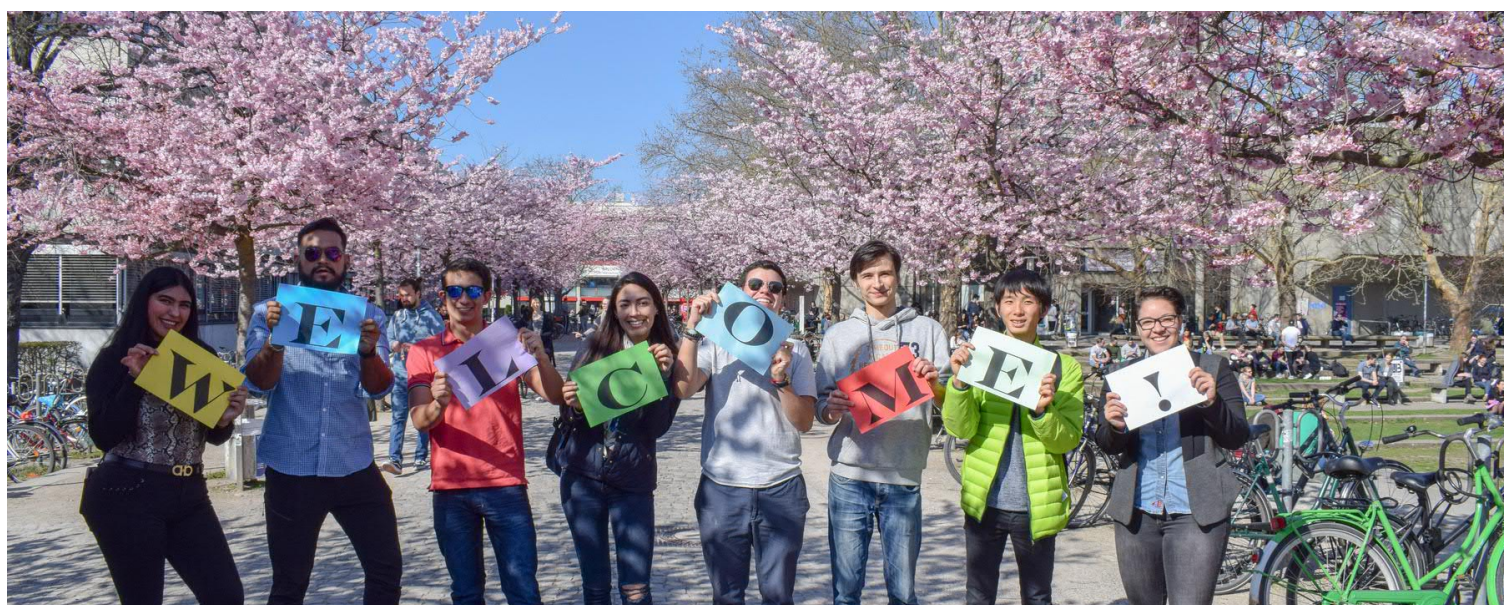


Application Procedure:

- Once you are nominated at your home University, your local coordinator sends your nomination to Christina Engelhardt (Coordinator at the Faculty of Business and Economics; incoming@wiwi.uni-goettingen.de) or to Christiane Seack (International Office Göttingen; christiane.seack@zww.uni-goettingen.de).
- The international office takes care of the [application procedure](#) afterwards.

Application deadline:

- 1st July 2021 for the winter semester 2021/22
- 1st December 2021 for the summer semester 2022
- With enrollment at our University, an organisation and semester ticket fee of around 300€ is due for one semester. With the included semester ticket, you can use public transport for free in local trains in Lower Saxony and city busses in Göttingen. You also enjoy benefits or free tickets for cultural events.



Studying in Göttingen:

- Most subjects in Göttingen are awarded with 6 ECTS, the recommended workload for one semester accounts to 30 ECTS. Exchange students can select [all courses from our study programmes in business administration or economics](#).
- Exchange students can take [German language courses](#) during the semester for free or an [intensive language course prior to semester start \(fee based\)](#).

Living in Göttingen:

- Cost of living: at least €600-800 per month in total
- Need assistance in finding an accommodation? Apply for the [accommodation service](#) from our international office! Only applicants before the deadline closes can be guaranteed accommodation.
- The closest airport is located in Hannover, the train takes around one hour to go to Göttingen from there. When you arrive at Göttingen train station our international office provides a [pick-up service](#) for you!
