Student Mobility:

The Georg-August-Universität Göttingen (UGOE) offers in all fields:

- Student mobility for studies with a duration of a minimum of 3 months.
- The mobility must be completed by 31st July 2023.

Insurance:

The grant holder is insured by a central Group Insurance, which the Project Coordination Team will centrally organize upon successful nomination. The insurance costs (approximately 1,49 EUR per day) are deducted from the individual support.

Please note that there was a change in German legislation related to the residence title for study purposes. In the future, all incoming international students are required to get German public health insurance. The law affects all mobilities from October 2018 onwards. The German public health insurance costs approx. 90-100 € per month. Upon your arrival/during the introductory days, you will be informed how to get this insurance.

Tuition fees:

The receiving institution will not ask the grantee to pay fees for tuition, registration, examinations, or access to laboratory and library facilities during his/her mobility period. Nevertheless, the grantee may be charged a fee on the same basis as local students for costs such as student unions and using study-related materials or equipment.

English: minimum B2 level

Staff Mobility:

The Georg-August-Universität Göttingen (UGOE) offers in the field of all fields:

- Staff mobility for teaching (from IISER to UGOE) with a duration of **up to one month** (excluding travel days).
- The mobility must be completed by 31st July 2023.

For teaching staff: A minimum of 8 hours of teaching per week at the host university has to be respected. Staff applicants should apply for the scholarship with an invitation letter from a potential supervisor of the Host University.
