Friction | Tensions, divisions and productive disruptions from gender perspectives

19th Workshop of the Commission for Gender Studies and Queer Anthropology of the German Society for Empirical Cultural Studies (DGEKW)

Based on the fact that more-than-human coexistence is fundamentally friction-filled (Bonacker 2009, Mouffe 2014), the conference asks how some constellations of friction lead to conflict, violence and division, while other differences are endured, even considered desirable or allow something new to emerge in a productively disruptive way. From a cultural-anthropological and gender perspective, answers must be sought empirically and ethnographically, taking into account the categories of gender and sexuality.

Accordingly, the conference asks what meanings different actors ascribe to certain gender, sexual and other differences, what means and arenas are chosen for the staging of conflicts over, for example, gender equality and influence their course, as well as how larger social fault lines shape, restrict or enable everyday life and agency. With this focus, the conference aims to bring together current academic findings on frictional dynamics in the area of gender/sexuality from various fields of research. It aims to foster a better understanding of the polarising and divisive dynamics both globally and locally by means of an empirically grounded analysis.

Antonio Gramsci's term 'interregnum', coined in 1926, is currently being used again to describe political and cultural-ideological crises and the associated polarisation and inability to reach a consensus (Laufenberg 2022). Often, tensions crystallise around the topics of gender/sexuality and become negotiated in an irreconcilable friend-foe register (Wielowiejski 2024). Numerous studies have recently emerged that empirically analyse how global and social fault lines emerge along a multitude of 'trigger points' (Mau et al. 2023) that shape, limit or enable the lived realities and opportunities of different actors: for example, studies engage with the dispute about how to adequately react to sexualised violence (Künzel/Bolz 2024) and critically analyse the discourse portraying Muslim men as sexist and homophobic (Hark/Villa 2017), they study and intervene into the debate about reproductive rights (Fröhlich et al. 2022) and point to the fact that contemporary authoritarian divides are resulting in new fragilities, especially for groups exposed to multiple discrimination (Bayramoglu/Castro Varela 2021). In the course of the recent politico legal shifts towards authroitarianism, gender studies itself has become a source of friction and a target of attack (Näser-Lather 2023, Hark 2017).

Nevertheless, numerous social movements and activist projects have been founded to counter violent divisions and at the same time search for a new common ground beyond romanticized notions of identity, community and sameness (Hark 2021, Hark et al. 2015). Building upon cultural-anthropological movement studies, current research focuses on how feminist or queer movements perform disagreement with a status quo that is experienced as violent (Heywood 2018), how they are shaped by internal disputes over means and goals, and the handling of difference (Gutekunst 2021), how they form solidary and caring alliances (Zengin 2024, Seeck 2021) and at the same time create utopias for the future beyond narrow gender norms and regulations (Sistenich 2025, Faust 2019).

The aforementioned efforts to unify also raise questions about how to deal with gender ambiguity and non-normative bodies and lifestyles. While liberalisation in the late 20th century led to a multiplication of gendered and sexual lifestyles and relationships and enabled new freedoms and rights for marginalised groups (Laufenberg 2022), early queer studies investigated the productively disruptive potential of non-normative willful subjects, such as ‘female masculinity’ (Halberstam 1998) or the ‘gender trouble maker’ (Butler 1990). They showed how transgressive figures can have a political-transformative effect in the sense of interrupting and irritating dominant gender relations. These spaces of possibility are currently threatened by re-traditionalisation, right-wing authoritarianism and ‘raw bourgeoisie’ (germ. “raue Bürgerlichkeit”, Heitmeyer 2012). Therefore, the conference also aims at mapping the remaining spaces and exploring the conditions of belonging.

Finally, the conference focuses on our own working practice: ethnographic field research is characterised by intense interaction between researchers and research partners. It presents researchers with the challenge of navigating epistemological differences and interpersonal tensions and using them methodologically. Cultural anthropology has developed methodological tools to use ‘friction as potential’ (Faust et al. 2021), to analyse ‘epistemic disconcertment’ (Verran 2001) and to use antagonism strategically (Wielowiejski 2024). At the same time, critical approaches call for a response to, and an intervention into the gender-political conflicts that shape the lives of our research partners. The proposed methodologies include forms of engaged, activist and advocacy anthropology (Binder/Hess 2013) as well as multi-sited research strategies tracing conflict constellation through – even violent – sites and scales (Riedner 2018, Hess/Tsianos 2020). Accordingly, the conference explores possibilities for collaborative and caring research in polarised fields and tense research relationships.
