GVBI. p. 69], as amended by Article 1 of the Act dated 27.01.2022 [Lower Saxony Law and Ordinance Gazette, Nds. GVBI. p. 54]; § 41 section 2 sentence 2 NHG; §§ 37, section 1, sentence 3 no. 5 b), 44 section 1 sentence 3 of the NHG).

# Examination and Study Regulations for the Master's degree programme "Modern Indian Studies" of the University of Göttingen

#### § 1 Scope

(1) The Master's degree programme "Modern Indian Studies" at the University of Göttingen is regulated by the "General examination regulations for Bachelor's and Master's degree programmes as well as other courses and degrees offered at the University of Göttingen" (APO) and the "General Examination Regulations for Master's degree programmes at the Faculty of Social Sciences" in their respective current versions.

(2) The present rules and regulations define further details and procedures with respect to this Master's degree programme, which are not covered by the general rules and regulations.

#### § 2 Programme Goals; Examination Objectives; Professional Fields

(1) The goal of the Master's degree programme "Modern Indian Studies" is to teach students in-depth specialised knowledge and enable them to grasp the complex issues connected with the subject and to apply the essential theories and methods. <sup>2</sup>Through the acquisition of well-

founded knowledge in the field of Modern Indian Studies and through interdisciplinary examination of the theories and methods applied in the different fields, students will learn how to independently formulate scientific problems and analyse social structures and processes in India, and will thus be able to understand problems in the field of Indian Studies.

(2) Training in the Master's degree programme "Modern Indian Studies" qualifies students to work in Indian and transnational enterprises, in development cooperation, in associations, in the administration and in government agencies, in NGOs, in tourism, and in media and communications. It also serves as a qualification to pursue postgraduate academic training.
(3) <sup>1</sup>In the Master's degree programme students are to acquire in-depth scientific knowledge

and the ability to conduct specialised and interdisciplinary scientific research independently and to apply scientific findings. <sup>2</sup>By imparting subject-specific knowledge and methodological-analytical abilities the programme prepares students for a successful career start and lays the foundations for continuing academic training in the context of doctoral programmes.

## § 3 Recommended Qualifications

Good knowledge of at least one modern Indian language is recommended.

#### § 4 Programme Structure

(1) <sup>1</sup>The standard period of study is 4 semesters. <sup>2</sup>The programme starts in the winter semester.

(2) The programme is not suitable for part-time studies.

(3) The programme comprises 120 transfer credits (ECTS credits, abbreviated: C) which are distributed as follows:

a. 78 C in the core subject studies Modern Indian Studies",

b. 12 C in the professionalisation area,

c. 30 C for the master's thesis.

(4) <sup>1</sup>The compulsory, elective compulsory and elective modules are defined in the module overview (appendix I). <sup>2</sup>Recommendations for appropriate ways to structure the programme can be found in the sample curricula in appendix II. The directory of modules is published separately in a combined electronic version; it is part of the present rules and regulations, as far as the modules are listed in the module overview (appendix I).

(5) <sup>1</sup>In the course of the study programme modules with a scope of at least 12 credits must be completed which focus on the acquisition of a modern Indian language; these modules may, as specified in the module overview below, be completed in the specialised Modern Indian Studies programme as well as in the practice-oriented training. <sup>2</sup>The examination board may

approve of exceptions, particularly in cases in which students already have knowledge of a modern Indian language.

(5a) <sup>1</sup>The study focus "Development Economics of India" can be completed within the scope of the core subject studies. <sup>2</sup>The admission requirement for the study focus is proof of basic knowledge of economics in the areas of microeconomics, macroeconomics, econometrics and development economics; proof is provided by the successful completion of the modules B.MIS.121, B.WIWI-OPH.0007, B.WIWI-VWL.0001, B.WIWI-OPH.0008 and B.WIWI-VWL.0041 or equivalent achievements for a total of 30 C. <sup>3</sup>The decision as to whether a previous course of study is subject-relevant in the aforementioned sense shall be made by the board of directors of CeMIS. <sup>4</sup>For the study focus, modules to the extent of 24 C must be completed, which deepen and differentiate development economics knowledge and competences in a compact form and thus enable a specific profile formation of the students within the framework of the overall interdisciplinary programme. <sup>5</sup>The topic of the master's thesis is to be chosen from the area of the study focus "Development Economics of India" in the case of completion of the study focus.

(5b) <sup>1</sup>Within the scope of the core subject studies, the study focus in "Historical Sociology" can be completed. <sup>2</sup>For the study focus, modules in the amount of 24 C must be completed, which provide knowledge and competencies in the historical-sociological research of the social transformations of modern India in its global in a compact form, whereby the aspects of capital, labor and state power are given special consideration. <sup>3</sup>The study focus enables the students to develop a specific profile within the framework of the overall interdisciplinary course of study. <sup>4</sup>The topic of the master's thesis must, in the case of the study focus of "Historical Sociology", be chosen from the area of this study focus.

(5c) <sup>1</sup>Within the scope of the core subject studies, the study focus "Anthropology of Power" can be completed. <sup>2</sup>For the study focus, modules in the amount of 24 C must be completed, which deepen and differentiate knowledge and competencies in the social and cultural anthropological study of cultural, social and economic differentiation processes and their power effects in the context of various power-structured fields of social practice in a compact form. <sup>3</sup>The study focus thus enables a specific profile formation of the students within the framework of the overall interdisciplinary course of study. <sup>4</sup>The topic of the master's thesis must, in the case of the study focus of "Anthropology of Power", be chosen from the area of this study focus.

(6) <sup>1</sup>In the course of the programme, key skills amounting to 12 C must be acquired in the professionalisation area. <sup>2</sup>In order to do so it is recommended to strengthen language skills

and to make use of the courses offered by the participating faculties (Economic Sciences, Social Sciences, Humanities).

(7) <sup>1</sup>The study and examination achievements in this programme are completed in the English language. <sup>2</sup>Students are allowed to take eligible elective compulsory and elective modules taught in German if they possess the necessary knowledge of the German language. <sup>3</sup>Proficiency in German is certified in accordance with the examination rules and regulations of the "Deutsche Sprachprüfung für den Hochschulzugang ausländischer Studienbewerberinnen und Studienbewerber (DSH)" in the respective current version. <sup>4</sup>The following students are exempt from taking a language proficiency test: students who are exempt from taking the "Deutsche Sprachprüfung für den Hochschulzugang ausländischer Studienbewerberinnen und Studienbewerber (DSH)" in the respective current version. <sup>4</sup>The following students are exempt from taking a language proficiency test: students who are exempt from taking the "Deutsche Sprachprüfung für den Hochschulzugang ausländischer Studienbewerberinnen und Studienbewerber (DSH)" at University of Göttingen; students who hold a German university entrance qualification; students who have completed their Bachelor's degree or an equivalent degree at a German university.

(8) The module overview also specifies the module package "Modern Indian Studies" which can be included in other Master's degree programmes to an extent of 36 C.

#### § 5 Studying Abroad

(1) <sup>1</sup>Students may in particular complete one semester at a higher education institution in India with which a cooperation agreement exists. <sup>2</sup>A list of the cooperating higher education institutions shall be announced once a semester by the Chairperson of the Examination Commission in an appropriate manner.

(2) For every student an individual "learning agreement" is to be concluded that determines which study and examination achievements are completed at the foreign university. The learning agreement must include only study and examination proposals which

- a) are essentially consistent with the difficulty level of a Master's degree programme,
- b) are consistent with the educational objectives of this Master's degree programme, i.
   e. which deal with one of the subject areas included in the interdisciplinary curriculum or included in the field of a modern Indian language, and
- c) are not the subject of a module examination that has already been taken or will be taken later in the course of this programme.

The learning agreement is approved by the examination board. The student may make recommendations regarding the nature of the agreement in line with b) and c); this right to make recommendations does not result in any legal entitlements.

(3) Notwithstanding section 1 above, the semester abroad can be spent at another research university in India, provided that the completion of a set of comparable, equivalent courses is guaranteed by means of a learning agreement. The respective decision is taken by the examination board upon the student's request.

#### § 6 Admission to the Master's Thesis

In order to be admitted to the master's thesis, students must have completed compulsory, elective compulsory and elective modules amounting to 60 C.

#### §7 Examination Organisation

If module descriptions of Modern Indian Studies (module numbers M.MIS, respectively B.MIS) contain alternative forms and scopes of assessment diverging from § 10 section 3 sentence 3 APO, the kind and scope of the examination achievement are determined by the examination board at the beginning of the semester and made public in a suitable manner.

#### § 8 Retaking Examinations to Achieve Better Marks

It is not allowed to retake examinations already passed in order to achieve better marks; § 16 a, section 3, sentence 2 of the general examination rules remains unaffected.

#### § 9 Student Advisory Service

(1) <sup>1</sup>Students may use the CeMIS advisory service throughout their programme. <sup>2</sup>It is the task of the advisory service to support individual planning of studies. <sup>3</sup>Students are recommended to consult the advisory service particularly at the start of the programme and with regard to decisions to change their study plans; furthermore, advice should be sought when planning studies abroad and after failed examinations.

(2) All lecturers and their staff members can be approached for subject-specific study advice during their office hours.

(3) A student will receive individual study counselling by a faculty lecturer if he or she has only one chance left to retake the examination of a compulsory or an elective compulsory module.

(4) In examination matters and with regard to questions concerning the recognition of study and examination achievements, counselling will primarily be provided by the staff of the Social Sciences examination office.

(5) <sup>1</sup>Apart from the Social Sciences student advisory office, students may consult the central advisory office of University of Göttingen. <sup>2</sup>It offers general information regarding problems going beyond the scope of one particular subject, as well as regarding study opportunities,

contents, structure and requirements of a given programme, and it will provide advice to students who are experiencing study-related personal difficulties.

#### § 10 Entry into Force

(1) These rules and regulations will entry into force on the day after their publication in the Official Announcements of University of Göttingen retroactively on 01.10.2015.

(2) At the same time, the examination and study regulations for the Master's degree programme "Modern Indian Studies" in the version announced on 30.09.2010 (Official Announcements no. 21/2010 p. 1649), most recently changed by the resolution of the Presidential Board dated 24.09.2013 (Official Announcements I 45/2013 p. 1822), shall be rendered invalid.

(3) <sup>1</sup>Students who commenced their academic programme before an amendment to these examination and study regulations came into force and who have remained enrolled therein without interruption, shall be examined on the basis of the examination and study regulations in place before the amendments came into force. <sup>2</sup>In the case of pending examinations, this does not apply to module overviews and descriptions, unless the legal entitlements of a student calls for a different decision by the examination board. <sup>3</sup>A different decision can be reached especially in cases where an examination can be repeated or a compulsory or elective compulsory module has changed significantly or been cancelled. <sup>4</sup>The examination board can draw up general rules for this purpose. <sup>5</sup>Examinations as per a valid version prior to an amendment of the existing of examination and study regulations coming into force, are conducted for the last time in the fourth semester after the amendment coming into force. <sup>6</sup>On application, students affected by sentence1 shall be examined in general on the basis of the amended regulations.

## Appendix I Module overview

## I. Master's degree programme "Modern Indian Studies"

A total of at least 120 C must be acquired. Within the scope of the degree programme, modules totalling at least 12 C must be completed which deal with the acquisition of knowledge of a modern Indian language; these can be completed in accordance with the following provisions both in the core subject studies and in the professionalisation area; outside the professionalisation area they are taken into account in the overall result of the master's examination up to a maximum of 12 C; insofar as a module can be selected in several elective compulsory or elective areas, it can only be taken into account in one of these areas after successful completion. The examination board may allow exceptions to this rule, especially if students already have knowledge of a modern Indian language or acquire it in another field of study.

## 1. Core subject studies "Modern Indian Studies" (78 C)

A total of 78 C have to be completed in accordance with the following regulations. Modules that have already been completed as part of a Bachelor's degree programme cannot be taken again. Students can either complete the elective modules (b) or one of the study focuses (c, d or e).

- aa) UNIcert®: at least certificate UNIcert® III;
- bb) NULTE-certificates: at least level C1;
- cc) Cambridge English Scale: at least 180 points,
- dd) "International English Language Testing System" (IELTS Academic): at least Band 6.5;
- ee) "Test of English as a Foreign Language" internet-based test (TOEFL iBT), at least 110 points
- ff) Global Scale of English (Pearson Academic): at least 76 points;

gg) other proof according to the Common European Framework of Reference for Languages (CEFR), at least level C1.

As a rule, successful completion of the test may not be more than two years prior to receipt of the application for admission to the Master's degree programme. Applicants with a study or professional stay of at least one year in an English-speaking country within the last two years before receipt of the application for admission to the module package are exempt from the obligation to provide proof of a test. Applicants who have successfully completed an English-language degree programme or part of a degree programme are also exempt.
