Conditions of participation - career fair PraxisBörse 2021

(English translation provided for informational purposes. If the English and German versions allow different interpretations, the German version should be followed. Only the German version of this document is legally binding.)

Organizer

The organizer of the PraxisBörse career fair is the University of Göttingen, Wilhelmsplatz 1, 37073 Göttingen.

2. Registration

- (1) Registration for participation in the event as an exhibitor is done by submitting the online registration form, completed in full.
- (2) The organizer shall not be liable for any consequences or damages arising directly or indirectly from incorrect, misleading, inaccurate or incomplete information provided in the registration form or on the basis of other communications with the exhibitor.

3. Confirmation of participation

- (1) The approval as an exhibitor takes place through the written confirmation of registration by the organizer. This establishes the contract between the exhibitor/company and the University of Göttingen in a legally binding manner.
- (2) In case of insolvency proceedings or insolvency of the exhibitor during the contractual relationship, the exhibitor is obliged to inform the organizer promptly.

4. Terms of payment

- (1) In return for the right to participate in the PraxisBörse event on 23 November and, if applicable, 24 November 2021, the exhibitor has to pay a participation fee. The participation fee is based on the type of booking and includes the use of the event platform/software and the fees for the second optional day of the trade fair (in presence or as a virtual trade fair).
- (2) An invoice for the exhibitor fee will be sent to the exhibitor. The invoice amount is due for payment in full within 10 days after the invoice date.

5. Event days

- (1) The PraxisBörse career fair will take place at the 23 and 24 November 2021.
- (2) On the first day of the event, the fair will be offered in a virtual format. This format is intended to ensure general feasibility (e.g. in the event of an ongoing pandemic situation) and to offer all participants (companies, trade fair visitors and internal facilities) the greatest possible planning security.
- (3) An event in presence is planned for the second day of the trade fair in the Central Lecture Hall (ZHG) Building. However, there is no guarantee that the second day will be held in physical attendance. In the event that due to the pandemic, face-to-face events are canceled by either the responsible authorities or University management, the organizer will switch to the virtual space for the second day as well. All exhibitors who have booked the second day of the fair exclusively as a presence event will be exempted from the participation fee for the second day of the fair; however, they will not be eligible for any claims for damages resulting from the change.
- (4) Exhibitors who have booked the second day of the trade fair (presence event) additionally with the option of the

substitute format (virtual event) will also participate in the second day of the trade fair for the corresponding participation fee.

6. Event times

- (1) The event will take place on both days of the trade fair from 12:00 to 16:00.
- (2) Should the event be cancelled after it has already started due to events beyond the organizer's control (force majeure), there is no entitlement for withdrawal from the contract or claims for damages.

Use of the stand

The exhibitor is obliged to use the stand (virtually and, if necessary, also in presence) in accordance with the conditions of participation and to keep the stand sufficiently staffed at all times during the opening hours of the trade fair. If the stand is not occupied by the start of the event at 12:00 or if the stand is left/dismantled prematurely before 16:00 on the day of the event, the organizer is entitled to use the stand for other purposes.

8. Cancellation

For cancellations after 30 June 2021, the exhibitor will be charged 50% of the total agreed-upon fee. For cancellations after 31 August 2021, the booking must be paid in full by the contractual exhibitor. If the exhibitor proves that the organizer has not suffered any damage as a result of the cancellation, or only damage that is significantly lower than the aforementioned amounts, the exhibitor shall pay the correspondingly reduced compensation.

9. Data collection

The collection of personal, non-anonymous data from trade fair visitors and other exhibitors is not permitted during the entire trade fair without the explicit permission of the organizer. Violations will result in immediate expulsion from the event. The booking fee for participation in the trade fair as well as additionally booked services (e.g. the sponsoring package or an advertisement in the trade fair catalog) must be paid in full. Lotteries in which no participation fee or personal data are collected are permissible as advertising measures.

10. Exclusion of liability

The organizer is only liable within its legal liability and excludes any liability for personal injury, property damage or financial losses beyond this, that occur on the event site. This also applies insofar as the damage is caused by employees and agents of the organizer. In particular, damage caused by fire, water, explosion, violent attacks, thunderstorms or other forms of force majeure or by theft, burglary or similar causes, by public traffic (in particular by trade fair visitors, other exhibitors, their agents, etc.), as a consequence of official safety regulations or by other circumstances for which the organizer is not responsible shall be excluded. This also applies in connection with grounds and buildings used during the event outside the exhibition grounds.
