Göttingen Welcomes Further Alexander von Humboldt Professor

The Mathematical Institute of the University of Göttingen is delighted to welcome Prof. Dr. Harald Andrés Helfgott, who will support the Institute from June this year. Helfgott was born in Peru in 1977, since 2010 he has worked as a senior researcher at the Centre national de la recherche scientifique (CNRS) in Paris. In addition, Helfgott is a member of the American Mathematical Society and the Société Mathématique de France.

The internationally renowned mathematician, who will help to advance the University of Göttingen to a global leader in the field of algebraic geometry and number theory, has been awarded an Alexander von Humboldt Professorship: the most highly endowed German research award funded by the Federal Ministry for Education and Research amounting to 3.5 million euro over a period of five years.

EU: Individual Fellowships for Postdocs

Within the Marie Sklodowska-Curie Actions (MSCA), which are a part of the European research framework "Horizon 2020", a call for "Individual Fellowships" (IF) was published. The application deadline is the 10th of September 2015. Researchers can apply for an "Individual Fellowship" if they have completed a doctoral degree or have evidence of four years of full-time research after completing their university studies. This funding programme aims to support research careers by means of international and intersectoral mobility. Researchers shall thereby either establish or strengthen their independent research position.

The research topic can be chosen freely, however, an essential requirement is mobility.

Researchers will be fostered by expanding and deepening their competencies in another country.

Scholarships from the Polish Ministry of Science and Higher Education



Once again the Polish Government is offering various assigned scholarships for the academic year of 2015/2016 for students, graduates, doctoral students and

scientists from German universities who wish to conduct their studies or research at a Polish university or college.

Thus, academics who fulfil the requirements above can generally apply three months prior to the intended beginning of the scholarship period. They can either apply for scholarships financing study and research stays (1-9 months) or for one-semester scholarships (4 months) exclusively assigned to applicants from Slavic Studies. Moreover, applications for research scientists from all academic fields for short-term scholarships (1-3 months) as well as for all other academics interested in summer course scholarships on Polish language and culture are also possible.

Scholarships from the Mexican Government

This year the Mexican Government offers scholarships for so-called "Special Programmes": Visiting lecturers, artists, specialists in Mexican Studies, employees working in the media sector and researchers have to commence their stay in Mexico beginning at the earliest in May and at the latest in October 2015. Scholarship holders will receive a monthly stipend, an international flight ticket and coverage of health insurance costs from the fourth month onwards. The application deadline for all programmes is the 14th of August, 2015.

For the so-called "Academic Programmes", scholarships will be offered for 2016: For consecutive postgraduate studies, Master's programmes, stays in connection to a doctorate, research stays for Postdocs or research stays for postgraduates as well as mobility programmes in order to obtain a first higher education degree (licenciatura) and also postgraduate programmes for the duration of month up to three years. The application deadline for these scholarships is the 31st of August, 2015.

In academia, the supervision of doctoral candidates can prove to be a daily challenge. Whether a PhD project turns out to be a success or a failure is not only influenced by the skills and the motivation of the doctoral candidates; the professionalism of the supervisor also plays an essential role. The latter is augmented particularly in the international context, e.g. the cultural and/or academic background of the candidate, the supervisor, or the institution they work for, can differ substantially.

Taking into account the different cultural backgrounds within the different scientific fields, as well as national

differences in academia, we will discuss questions and present tools, which help to avoid or overcome problems. As a result of the workshop, participants

- will gain knowledge of the different phases of a doctoral project and the obstacles which may arise throughout;
- · will be aware of the different roles that have to be considered when supervising doctoral candidates;
- will have gained skills to circumvent and to overcome problems.

All academics that are involved in the process of PhD supervision are welcome to participate in the course, which will be held in English.

Göttingen Conference on Labour Standards in International Economic Law



The ever-intensifying globalisation and interdependence of the international economy, framed by the rapid evolution of inter-

national economic law, brings about new challenges for the protection and promotion of labour standards.

Labour standards play an increasingly important role in regional trade agreements, unilateral preference schemes, international investment agreements and in a range of non-state initiatives. At the same time, the International Labour Organization is increasing its efforts to readjust its mandate and capacities in order to properly address the challenges posed by globalisation. The plenitude of different (and sometimes conflicting) approaches shapes

a multilevel and multipolar status quo, the structure and potential of which is yet largely to be discerned.

On the 1st and 2nd of October 2015, the Institute for International Law and European Law, Department of International Economic and Environmental Law, will host an international conference, inviting academics and practitioners from around the world to engage in discussions on some of the most pressing issues at the tangent of international economic law and international labour standards.

German-Turkish Workshop on Neurosciences



Deutsch-Türkisches Jahr der Forschung, Bildung und Innovation 2014

In course of the German-Turkish Year of Research, Education and Innovation 2014 the University of Göttingen and the Boğaziçi University in Istanbul hosted a

series of workshops in the field of molecular neurosciences. The Year of Science was run under the tagline "Science Bridging Nations" and activities have been developed to continue beyond the horizon of 2014.

The University of Göttingen successfully applied for funding within the Ideas Competition, which was launched by the BMBF as part of the German-Turkish Year of Science. In September 2014, Göttingen PhD students and scientists visited Boğaziçi University in Istanbul to discuss recent developments in the neurosciences. In return the Department of Developmental Biochemistry chaired by Prof. Dr. Pieler invited Turkish PhD students and researchers to take part in the

"NeuroTurk - German-Turkish Young Scientists Workshop on Molecular Neurosciences", which took place between the 26th and 29th of May in Göttingen. At a scientific symposium the Turkish guests presented their research projects together with the PhD students of the Göttingen Graduate School for Neurosciences, Biophysics, and Molecular Biosciences. Thus, the students had the opportunity to introduce their projects to an international audience and to gain experience in a debate on their results. For the future, a partnership between both universities in research and teaching will be facilitated based on these activities and on existing contacts.

ERC Grant for Göttingen Chemist Sven Schneider



The European Research Council (ERC) has awarded a Consolidator Grant to Prof. Dr. Sven Schneider from the Institute of Inorganic Chemistry of the University of Göttingen.

The ERC funds his project "N2 as Chemical Feedstock – Synthetic Nitrogen Fixation beyond Haber-Bosch" with

about two million euro starting in June 2015 for a period of five years.

For this project, Professor Schneider and his team will examine elementary reactions which enable the development of new catalytic synthesis pathways of nitrogenous compounds.

In industry, ammonia is essential for the production of fertilizers, but also needed for synthetic organic materials, like polymers or pharmaceuticals. Within the so-called Haber process, nitrogen from the air is converted into ammonia upon reaction with hydrogen. "The industrial production of ammonia through the Haber-Bosch-procedure is very costly and consumes approximately two per cent of the energy used worldwide", explains Schneider. "In our project, we are searching for alternative procedures." Further information can be found at www.uni-goettingen.de/en/356646.html.

Three Years of Sino-German Forestry Research

Sandstorms, soil erosion and floods are only some of the consequences of the massive deforestation in China from the mid-20th century. For the last 30 years, however, the Chinese Government has reacted to these environmental challenges in an equally massive manner and has initiated huge reforestation projects. Today, already 22% of China is covered with forest while in 1978 it was only 5%.

After dealing with the great challenges of reforestation, methods for the sustainable sustenance of forest are now in demand. The aim of the methods is to convert the plantations into stable, productive forests with a focus on the conservation of biodiversity. To give forestry firms and communes an incentive, the Chinese carbon market plans to implement market-mechanisms for the trade with carbon dioxide certificates on a national level by 2017. As forests remove a large amount of carbon from the atmosphere and store it over long periods of time, the issue of carbon certificates may be an attractive option for Chinese forest managers.

To aid preparations of the Chinese forestry for the upcoming carbon market, was the focus of the Lin2Value project that the Chair of Forest Inventory and Remote Sensing of the University of Göttingen (Prof. Dr. Christoph Kleinn) implemented in the mountainous forests of the Anhui province (partner province of the Federal State of Lower Saxony since 1985). This three-year scientific cooperation project was funded by the Ministry of Education and Research (BMBF) with 1.7 million euro.

Objectives of Lin2Value were to develop adapted forest planning methods regarding inventory and mapping of the forests. The project also included the development of methods to quantify the role of forests as a carbon sink, and the development of silvicultural strategies; the latter was implemented by the Chair of Silviculture and Forest Ecology of Temperate Zones (Prof. Dr. Christian Ammer).

A further emphasis in the context of the internationalisation of the Faculty of Forest Sciences and Forest Ecology in Göttingen was to support young forest professionals and to establish working platforms for their scientific exchange in the field of forest management.



An excellent scientific cooperation with the Chinese Academy of Forestry (CAF), the International Center for Bamboo and Rattan (ICBR), the Anhui Agricultural University (AAU) in Hefei and with the local forest authorities was established. Long-term observation plots were installed and huge amounts of data was collected and analysed. The integration of young scientists resulted in two bachelor theses, three master theses and three dissertations. At the final workshop in March 2015 in Hefei and Beijing, the results were presented to representatives of the State Forest Administration of China and to Colleagues from different forest faculties in China.
